How to Run an SSV Round Robin Tournament

1. **Before event**, print out **tournament player listing** from SSV/Los Angeles, San Diego or Orange County page. Use the listing to check players in and mark them paid. (the listing will also show who is new to the tournaments and needs a **new player pic**.) If there are not enough courts available, contact SSV to post a second check-in time.

2. **Before event**, print out **drawsheets** (round robin, 6 player draw).

3. **Check Player in**. Take player payment, cash or check (tell parent who to write the check out to). Have petty cash for big bills.

4. **Take new player pic.**



5. **Send kids out to courts to warm up.**

6. After everyone has checked in, **create groups** by SSV ratings on the draw sheets. Ideally groups of 4 are best, but groups of two, three, five and six can also be used. Ideally, you should group juniors within 10 points of each other's ratings. Check **SSV Round Robin Draw** on **how many games** are played for each group, **how to select matches** and **how many courts you'll need**.

7. **Bring kids back** from courts.

**PLAYERS WITH MOST SETS AND GAMES WINS THE GROUP
IN A TIE OF SETS AND GAMES, BOTH JUNIORS GET TROPHIES**

8. **Explain rules**, games, sets and tiebreakers to players. Tell them to come back to you with results. As tournament director, let them know that any *disputes or questions* should be brought to **you**.



9. If possible, **Take group pic** for the SSV newsletter. It's a fun reminder of the kids' day.

10. **Assign players to courts**. You'll need a new can of balls for every court you're using, so remind them to **keep the balls on the court** for the next players to use.

11. **Write down match results** and reassign new matches.



12. **Announce winners of each group** and hand out trophies.

13. **Take individual pics of trophy winners** for SSV newsletter.

14. **Write down all players set and game totals** on right side of drawsheets and email results (group names, player names, sets won, games won) to info@ssvtennis.com. Or, take bright, clear pics of the completed drawsheets and email them. **Please include full names of players who dropped in and no-shows.**

15. Finally, **email new player pics**, trophy winner pics and drawsheet results pics to info@ssvtennis.com.
